
## NATIONAL PET DAY

# **TEXTING 9-1-1**

South Dakotans now have the option to text 911 when they're unable to make a 911 call.

The text, like a phone call, will be routed to a local dispatch center. The new texting option is part of the state's 9-1-1 Coordination Program.

Officials said texting should only be used when someone can't safely make a voice call, such as in situations involving an active shooter, domestic violence or a home invasion. Texting to 911 can also be used by people who lose the ability to speak because of a medical crisis.

The South Dakota Department of Public Safety issued some guidelines, including first texting location and type of emergency. Photo or video texts cannot be received by dispatchers.

### OFFICIAL NOTICE OF DIRECTOR ELECTIONS

A total of five directors will be elected at the 2021 annual meeting, which is scheduled for August 5th, 2021 at the high school in Groton. Wendell Rye (District 2) and Mark Wattier (District 6) are up for re-election for 3-year terms.

Due to the postponement of the 2020 annual meeting and pursuant to the Bylaws, Roger Zastrow (District 1), Bill Ewalt (District 4) and Garrett Rahm (District 7) are up for reelection for 2-year terms.

Anyone interested in running for an open director position, in the district in which they reside, should file a nominating petition signed by at least fifteen members also residing in that interested member's district.

The petition can be picked up anytime during business hours at JVT's office and must be returned and filed at JVT's business office between the hours of 8am-5pm no sooner than June 7 and no later than June 21.

At the annual meeting, members from each district in which a director is being elected will receive a ballot listing the names of all the candidates who have submitted valid petitions for that district. The candidate receiving the majority of votes cast for each district will be elected.

**Bylaw Section 4.3.** Qualifications to be Nominated, to Become, or Remain

District 1 Houghton - Columbia Frederick a Director. Any member shall be eligible to be nominated, elected and remain a director of the Cooperative who resides in the district from which the director is nominated and is not an employee of the Cooperative or in any way financially interested in a competing enterprise or a business engaged in selling communication services or communication supplies or maintaining communications facilities. However, the Board may grant exceptions for "de minimis" competing enterprise. The director is expected to attend two-thirds or more of the regular meetings during each twelvemonth period beginning with the month of the director's election.

**ROGER ZASTROW** 

Nothing in this Section shall affect, in any manner whatsoever, the validity of any action taken at any meetings of the Board.

Bylaw Section 4.4. Candidate Petitions. Any member who meets the qualifications of Section 4.3 and wishes to appear on the ballot for election as a director for the member's district, shall, not less than 45 nor more than 60 days preceding the day designated for the annual meeting, file during business hours at the business office of the Cooperative, a nominating petition signed by at least fifteen members residing in such member's district. The petition shall be in a form approved by the board of directors. The signature of only one member of a joint membership may be counted among the valid signatures on a

petition, and any other signatures on the same petition by other members of the same joint membership shall be stricken.

**Bylaw Section 4.5.** Election of Directors. Elections of directors shall be by a separate printed ballot for the exclusive use of the members of each district in which a director is being elected. Each district's ballot shall list the name(s) of the candidate(s) who have submitted valid petitions, the order of which shall be determined by drawing of lots.

At the membership meeting considering the election of directors, the Secretary of the Cooperative shall place in nomination the names of all those who have submitted valid petitions.

The candidate from each district from which a director is being elected receiving the majority of votes cast for that office at such meeting shall be declared elected as a director. At least seven members from that district must cast votes at the membership meeting for the election of the director to be valid.

Failure of an election for a given year shall allow the incumbent director whose directorship would have been voted on to hold over only until the next member meeting at which a quorum is present.

Director petitions must be filed at JVT's office between June 7 and June 21, 2021.
